### §7 Right of withdrawal and return, cost of return

Worn or washed ware cannot be returned. Labels must not be removed.

#### §8 Guarantee

Imperfect ware will be replaced by us in any case. We are authorized by own choice for an alternative shipping, redhibitory action or abatement according to law. The customer has to inspect the product within 14 days after shipping and immediately return it in case of any deficit. If the customer fails to do so the delivered ware counts as approved except in case of a deficit being invisible at this time. Should such a deficit be identified later it has to be announced immediately or the product counts as approved concerning this deficit.

Is the damage or a deficit externally visible only objection of unused ware is allowed.

The bleeding of piece-dyed ware is production-related and excludes any claim for redhibitory action, abatement or change.

In controversial objection cases the judgment of an arbitrative board is deciding.
